No refunds will be made for no-shows, late arrivals, early departures or any unused services.

Bookings Cancelled by Supplier

While Up And Go makes every effort to engage Suppliers who offer quality accommodation, it does not have direct control over the services provided by suppliers and shall not be liable for any loss, damage, injury, additional cost, accident, power outage, plumbing or other irregularity that may be occasioned by any error or default, act or omission of any supplier in carrying out the reservation arrangements.
